

# 2<sup>nd</sup> International wood sculpture Symposium August 2 to August 8, 2020



The A.S.U.C. di Coredo and the Municipality of Predaia organize during the week **from Sunday, August 2 to Saturday, August 8, 2020** the 2nd edition of the International Symposium on wood carving as part of the project **“Predaia Arte e Natura – Sentiero, Simposio, Festival”** in Coredo di Predaia, under the artistic direction of the Marte studio of Gianni Mascotti.

On the wonderful experience of the last edition and the 17 past editions of the Symposium **“Il legno riprende vita”**, the project will transform, once again, the town of Coredo in Val di Non into a wood workshop, in which **6 selected sculptors** they will be able to give free rein to their art.

A further sculptor will take on the innovative artistic proposal **“Colomela Art”**.

The symposium will take place in the Coredo district of the Municipality of Predaia, at the **“Due Laghi”** locality, connected to the town by a suggestive 15-minute walk called **“il Viale dei Sogni”**.

The event will not see a single winner, but each participant will be awarded a fee of € 800.00 (gross amount) for the realization of the work.
